Election of elected Senate Members to Senate Standing Committees

How we will use information about you

The information you provide will be used by the University to run the election of elected Senate Members to each of the three Senate Standing Committees. Senate elections are conducted by Civica Election Services (formerly Electoral Reform Services) and supported by Academic Services. This Privacy Statement is relevant to the records held by Academic Services, and shared with Civica Election Services (formerly Electoral Reform Services) for the purposes of conducting the election. Records of the electoral process itself are held by Information Services Group and are not covered by this Privacy Notice.

If you stand for election, your name, personal title (if supplied), College / Unit, your status as a previously elected Standing Committee member, the Standing Committee you would like to be elected to, and your Candidate Statement provided on your nomination form, will be made available to current elected academic staff, Senate Assessors and the Academic Staff Member of Court during the election period via the Senate website. The web pages holding candidate information are EASE protected.

If you are elected to a Senate Standing Committee your name, College / Unit, and status as an elected member of Senate will be publically available on the relevant Senate Standing Committee website.

How long the University will hold this information

If you choose to nominate yourself for election to a Senate Standing Committee by completing the relevant Election Nomination Form, we will hold the personal data you provide to us, for both successful and unsuccessful candidates, for 6 months after the date of the relevant election.

If you are elected to a Senate Standing Committee, we will record your details on the relevant Committee membership list. At the end of the relevant retention period these lists are transferred to the University archive and kept in perpetuity.

How long Civica Election Services (formerly Electoral Reform Services) will hold this information

If an election is required, this will be conducted by Civica Election Services (formerly Electoral Reform Services). Once the election has concluded and the results have been declared, the election data is anonymised and held for the purposes of statistical reporting only. All personal data is permanently deleted once the election has concluded and the results have been declared. Records of the electoral process itself are held by Information Services Group and are not covered by this Privacy Notice.
