## How we will use information about you

Should you choose to engage with any of these processes, the University will use information about you to determine the nature of the impact of your circumstances on your studies, and to decide what the most appropriate course of action should be in relation to your studies.

The University does not use automated decision making or profiling as part of the Exceptional Circumstances, Authorised Interruption of Studies, Leave of Absence, or Concessions processes. A human decision maker will always be involved before any decision is reached in relation to you. Applications for Coursework Extensions will be automatically approved where you select a valid reason for an extension, and have remaining extensions available to you.

This information will be handled and processed confidentially. All staff involved in the handling and processing of sensitive personal data or Special Category data have a duty of confidentiality in relation to the content and processing of this data.

The University of Edinburgh will not share your information with any third parties, unless required to do so by law.

Information that you supply as part of the Exceptional Circumstances process will be destroyed confidentially 1 year after you have graduated.

Information that you supply as part of an Authorised Interruption of Studies application will be destroyed confidentially 1 year following your graduation, or other permanent departure from the University.

Information that you supply as part of a Concession request will be destroyed confidentially 1 year after you have graduated.

Information you supply as part of a Coursework Extension Request will be destroyed 1 year after you have graduated.

Information that you supply as part of a Leave of Absence request will be destroyed 1 year after you have graduated.
